Annual Finacial Report 2016

Overview 2016

During 2016 the assossiation's activities raised \$ 25,434. This was a busy and successful year and we were able to donate over \$ 27,000 back into our school.

We have closed the year with a healthy cash balance of \$44,149.

Funds contributed to the school included \$ 5,000 towards new Office equipment, \$ 5,000 towards the Aruba WiFi, \$ 12,040 towards new Chromebooks and storage, \$ 2,463 towards a PA system, \$ 600 towards the vegetable garden as well as contributions to the school for such things as allocations to classrooms for teacher discretionary items.

The main contributors to fundraising were the Canteen with a gross fundraising of \$ 9,778, the Sunday markets with \$ 9,688 and general fundraising events with \$ 6433. A breakdown of our fundraising events is given below.

Principals Report - Leura PS - P&C AGM 2016

The school community at Leura are extremely lucky to have such a wonderful, supportive Parents and Citizens Association. Throughout 2015, the LPS P&C Association has worked tirelessly, in conjunction with a dedicated group of teaching and support staff, to ensure the success of each and every individual student at Leura.

In 2015 the school participated in a number of activities to enhance the opportunities available to all students. Some of our highlights in 2015 include;

Creative Arts

In the performing arts, a large number of students at Leura PS participated in the instrumental music program, recorder ensemble, school choirs and school dance groups. Our school choirs had a successful year and were provided with opportunities to perform at the Sydney Town Hall, Sydney Opera House and Upper Blue Mountains Music Festival. 4 students at the school attended the Western Sydney Regional music camp, and our school dance groups performed wonderfully at the Nepean Dance Festival. In December, the school held it's Music and Art showcase to acknowledge the hard work and commitment the students at LPS put into the creative arts. In visual arts, 4 students exhibited artworks in the Operation Art exhibition held annually at Sydney Olympic Park.

Sport

The students at Leura PS continue to enjoy a range of experiences and opportunities on the sporting field. It was wonderful to see so many of the students represent our school across all levels of sport. Each year, students participate in Swimming, Cross-Country and Athletics carnivals, and it is pleasing to note that a number of students went on to represent the school at Zone, Area and Regional carnivals throughout the year. In term one, 2 students went on the represent the school at the Regional Swimming Carnival. 5 students were successful in representing LPS at the area Cross-Country, and in term three, 6 students went on to participate in the Regional Athletics Carnival. Our K-2 students enjoyed participating in what was a hugely successful K-2 Sports Carnival. In addition to involvement in various sporting events the students also participated in AFL and soccer gala days, a comprehensive athletics skills program, the AFL Auskick program, and we were well represented at the Milo T20 Blast entering 3 teams in the competition.

Other highlights and key events in 2015

- Implementation of new School Planning model as part of a range of reforms within the education sector across NSW. LPS implemented the new school planning model in line with DoE guidelines.
 The new 3-year plan incorporates strategic directions which relate directly to various areas of school life including student wellbeing, engagement, learning skills and understanding how we learn.
- Implementation of KidsMatter The KidsMatter program is a mental health and wellbeing
 framework for primary schools proven to make a positive difference to the lives of Australian
 children. The program provides the methods, tools and support to help schools work with parents
 and carers, health services and the wider community, to nurture happy, balanced children.
- Participation in various events including Clean Up Schools Day 2015, National Ride2School Day, Worlds Greatest Shave Day which raised over \$1000 for the Leukaemia Foundation, Tour De Cure in aid of cancer research and supporting people living with cancer which raised approximately \$600
- Establishment of the Live Well at Leura Vegie Garden.
- Participation in the Katoomba ANZAC Day March where over 35 children resented LPS
- Establishment of a Student Representative Council to provide the students of LPS with a voice and opportunity to participate in decision-making processes within the school.
- A hugely successful Book Fair and Book Character Parade in term 2.

- Parent teacher interviews in term two and comprehensive student reports in term two and four to report on student achievement and progress.
- Participation in the Principal for Day program.
- · Participation in the Paper Plane Challenge and a second place in the state.
- Walk for Wi-Fi this school fundraising effort raised over \$7000 which enabled the purchase of multiple Aruba units to increase and enhance the availability of Wi-Fi at Leura Public School.
- Parent information sessions including Cyber safety, Wellbeing, Mental Health and Kindergarten Orientation programs.

Performance against the School Excellence Framework

This year, our school undertook a self-assessment using the School Excellence Framework. The School Excellence Framework supports public schools throughout NSW in the pursuit of excellence by providing a clear description of high quality practice across the three domains of Learning, Teaching and Leading.
